Group CEO Business Presentation

The Group CEO, David Marsh welcomed all members and guests; and thanked the current Board for their commitments to the Club over the past 12 months. The Group CEO thanked Terry Green (Secretary Manager of TBBC) and the Senior Management Team for their attendance.

Business Overview – TBBC

- Previous Year:
 - First time a Net Profit recorded
 - Financial support of \$35,000 provided to local community groups
 - Club was successfully represented at Club, District, Zone and State levels
 - Club proud hosts of NSW State Police Bowls, Wallis Lake Mixed Pairs and the Annual Women's Bowls NSW State Championships
- O Continued Investment:
 - Capital Investment of \$479,000. Major items included poker machine upgrades and entitlements; and audio visual equipment for auditorium
- Debt Reduction:
 - Reduction in Intercompany Debt from \$500,000 to \$100,000
- Operational Review:
 - Resulted in improved financial outcome
- 3-5 Year Strategic / Master Plan:
 - Critical that TBBC remain financially stable over the coming years

2. Business Overview - Tuncurry Beach Motel

- Previous Year:
 - Successful year with substantially improved profit
 - Operational review included reduction in costs, new motel operators and the introduction of online marketing and booking system
- Continued Investment:
 - Internal upgrades included tiling, bathroom renovation; new beds, microwaves and sofas
 - External upgrades included painting, office door replacement, new pool filter and introduction of CCTV

3. Business Overview - Hawke Street Holiday Units

- Continued Investment:
 - Upgrade of in-room facilities continues
 - Replacement of current roof (in urgent need of repair)


4. Business Overview - Group

- Amalgamation Wallacia Bowling & Recreation Club (Wallacia):
 - Amalgamation became effective 14 September 2016
 - Liquidation process is underway and will be formalised at a Wallacia Member's Meeting on 7 December 2016. Once process is complete the Club will trade as Club Wallacia
 - Memorandum of Understanding (MOU) is currently being implemented
- Constitution & By-Laws:
 - Amendments made to Constitution and approved at 2015 AGM have now been actioned
 - By-Laws are modified by the Board throughout the year to reflect changes in the law or business requirements
 - Amendments to Constitution or By-Laws under the approved Wallacia MOU will be actioned as required
- SJPBC Renovation Update:
 - Capital Investment >\$12M. Major items included new pub style Bistro (Swish Pub Grub | Pizza); new coffee shop (Baking Room); new pub style function centre (Pavilion Bar); and new Asian dining experience (Xi Yan Asian Cuisine)
 - Council have approved Development Application (DA) to build Administration facility on first level of Pavilion Bar
 - Awaiting DA approval from Council to build additional carpark levels, which includes 240 car spaces
 - Gregory Hills development plans currently on hold
- SJPBC Strategic Plan:
 - Currently in 4th year of planning
 - Agreed branding strategies being delivered
- SJPBC Bowls Strategic Update:
 - Investment commitment of >\$200,000 in next 12 months to include:
 - new shades around Greens
 - new bowls benches
 - new electronic scoreboards for all Greens
 - replacement of turf on Greens 1 & 3
 - replacement of banks on all Greens
 - new designated smoking areas around Greens
